Respond to an Initiative

1. From the Oracle Homepage, scroll to the Things to Finish section and click the applicable notification.

Note: The notification will be in the format "You Are Invited to Respond to Questionnaire #(Initiative Number) for Supplier ***Supplier Name.





2. In the pop-up, click **Respond to Question naire**.
