

Mandatory Recycling Reciclaje obligatorio AB 341

The law states: La Ley Estipula:

To conserve diminishing landfill space and natural resources, California adopted Assembly Bill 341 which sets a Statewide recycling goal of 75% and mandates recycling in the commercial sector. Effective July 1, 2012, businesses that produce at least 4 cubic yards of trash a week must participate in recycling through one of the following:

- Subscribe to a service that collects recyclables separately
- Subscribe to a service that sends materials to a mixed waste processing facility that diverts recyclables
- Self-haul your own recyclables

Commercial **ORGANICS RECYCLING** Phase 2: January 1, 2017

State law (AB 1826) requires businesses and apartment complexes that generate a certain amount of organic waste to arrange for organic waste* recycling. The following chart shows Phase 2 & 3 of the state-mandated implementation schedule.

Date	Generated Organic Waste
January 1, 2017	4 cubic yards or more of organic waste per week
January 1, 2019	4 cubic yards or more of solid waste per week

*Apartment complexes are not required to have a food waste diversion program.

What is Organic Waste?

Organic waste includes food waste, food-soiled paper, landscape and pruning waste and non-hazardous wood waste.
