Tri-CED's Feet on the Street Recycling Audit Program

Tri-CED's Feet on the Streets recycling audit program helps residents recycle with confidence by providing real-time feedback right at the cart.

On collection day, Recycling Assessors will check carts and leave a friendly "Oops Tag" with instructions on how to recycle properly if items don't belong. The goal is to reduce contamination and make recycling easier for everyone.

With about 17,000 households in Union City, every effort matters. Trucks empty residents' recycling carts on collection day, then deliver the material to Tri-CED's recycling plant in Union City to be sorted. Help Tri-CED sort better by recycling right! Thank you for doing your part!

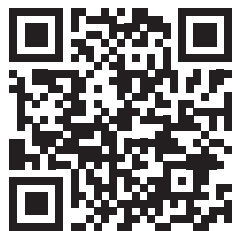
Pumpkins Are Compostable

Remove any candles or decorations, and simply put it in your green cart. Pumpkins collected through the compost program will be transformed into compost, which can be used to nourish plants and trees.



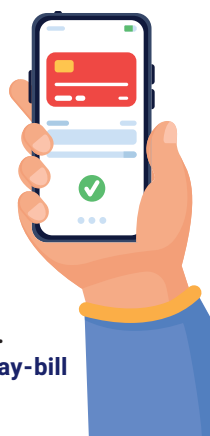

Curbside Collection of Batteries, Cellphones, Used Motor Oil and Used Motor Oil Filters

If you live in a single-family home or townhouse with individual recycling cart service: Put loose batteries into a clear gallon-size zip-top bag and place on top of your recycling cart on collection day. You can also call Tri-CED Community Recycling at **510-471-3850** to request a clear zip-top bag. For information on convenient battery and cellphone drop-off locations, visit: UnionCity.org/EWasteRecycling.

Remember, safety first!

Please take special care with Lithium batteries. These batteries are stamped with "Lithium", "Li" or "Li-ion". Please tape over the ends of these batteries before recycling. If left uncovered, they can cause fires if they come in contact with other batteries.

Acceptable Batteries: AAA, AA, C, D, 9-volt, alkaline, rechargeable, lithium and coin cells, small button-size hearing aid cells.

Prohibited: Car batteries are not accepted. For information on how to safely dispose of car batteries, visit: StopWaste.org/ReSource.

Used Motor Oil and Used Oil Filter Recycling

Containers for recycling used motor oil and used oil filters are available to Union City residents at no additional charge. Contact Tri-CED at **510-429-8030** to request a jug for used motor oil and a bag for used oil filters. You may place a maximum of two fully sealed, one-gallon jugs of used motor oil at the curb on your regular weekly collection day. Never mix used motor oil with any other automotive products or fluids.

Free Household Hazardous Waste (HHW) Drop-Off Program

The Alameda County HHW Program accepts up to five (5) gallons of used motor oil, used oil filters, anti-freeze, and batteries. When recycling a used oil filter, be sure to drain it before placing it in a leak-proof, tightly sealed plastic bag. Never mix used motor oil with any other automotive products or fluids.
