

# What is SB 1383?

In September 2016, Governor Brown signed into law SB 1383, establishing methane emissions reduction targets in a statewide effort to reduce emissions of short-lived climate pollutants (SLCP) in various sectors of California's economy.

**To cover the increased cost of compliance with SB 1383, a 19.89% rate increase is needed, effective January 1, 2024.**

Under SB 1383, businesses are required to separate organics, including all food scraps, uncoated food-soiled paper and yard trimmings for composting. All businesses must have compliance audits to verify they are recycling, participating in their organics program and educating their employees. ## Food Recovery
