Apartment/Condo Recycling Laws

SB 1383: Reducing Organic Waste

State law, SB 1383, is a statewide effort to reduce emissions of short-lived pollutants by reducing organics waste disposal to 75% by 2025. Organic material accounts for more than half of the material in California's waste stream. Greenhouse gas emissions caused by the decomposition of organic material in landfills contribute to global climate change. As of January 2022, residents are required to separate organics, including all food scraps, uncoated food-soiled paper and yard trimmings, for composting. Go to calrecycle.ca.gov/organics/slcp, for more information. Property managers are required to:

- Annually educate tenants on the legal requirement to separate organics for composting, and how to properly sort materials (organics, recycle and landfill). Residents can participate by preventing/reducing food waste, composting at home and using the green organics cart.
- Provide information to new tenants within 14 days of occupation of the premises.

Mandatory Commercial Recycling

State law, AB 341, requires apartments and condo complexes generating 4 cubic yards or more of trash per week to have a recycling program. For more information about AB 341, visit: calrecycle.ca.gov/recycle/commercial.

On Call Cleanups

As part of your garbage and recycling service package, Republic Services will provide your complex with three (3) 20- to 40-yard debris boxes per year for designated cleanup material.

Cleanup Options

You can choose to have either:

- Three cleanups with one debris box per cleanup;
- Two cleanups with 2 debris boxes for one cleanup and one debris box for the third cleanup; or
- One cleanup using all three debris boxes.

Only a property manager, owner or designated representative may schedule a cleanup. To schedule a cleanup, or for more information, call 925.671.5806.

Unacceptable Items for Cleanups

- No large car parts (tires, transmission blocks, engines, etc.) or large furniture (including mattresses and box springs).
- No refrigerators, freezers, air conditioners or any other appliance with Freon.
- No appliances such as microwave ovens, space heaters, clothes dryers and others that have mercury switches.
- No rocks, dirt, or concrete.
- No tree stumps or large tree trunks.
- No TVs or computer monitors.
- No hazardous wastes including paint, oil filters, motor oil, car batteries, anti-freeze, solvents, pesticides, cleaners. For more information call 800.646.1431.

Keep Recycling Clean

To meet strict quality requirements in this new era of recycling, please make sure your recyclables are:



Empty. Remove any remaining food or liquid.



Clean. Wipe or lightly rinse the item.



Dry. Shake out excess moisture or air dry.

Food Scrap Composting



Use the pail for storage before emptying food scraps into the green organics cart. Line your food scrap pail with newspaper, a paper bag, or a BPI-Certified Compostable bag (the only type of Compostable plastic we can accept).
