Assembly Bill AB 660:

Simplifying Food Date Labels

Have you ever thrown away food because the date on the package had passed? California's food date-labeling requirements changed on July 1, 2026, to make labels easier to understand and help reduce food waste. Under Assembly Bill ("AB") 660, consumer-facing "sell by" dates are no longer allowed on most products. Instead, qualifying products use standardized terms that tell if you a date relates to food quality or food safety. A **quality date** generally indicates when food is expected to have its best flavor or quality, while a **safety date** tells you when food should be used or frozen by for safety.

Senate Bill ("SB") 1383 is an ongoing statewide effort to reduce organic waste disposal and food waste. With a proper understanding of food date labels and their meanings, you can help contribute to this effort and reduce food waste by preventing perfectly edible food from being thrown out.

Manufacturers Food Date Labels:

- **"BEST if Used By" or "BEST if Used or Frozen By":** Quality dates that indicate peak freshness (or quality) of a food item
- **"USE By" or "USE By or Freeze By":** Safety dates that indicate when a food item is no longer safe to eat
