



Scaling Reliable Waste Management for a Multi-site Healthcare Network

Over the past five years, Republic Services has partnered with a nationwide healthcare provider to simplify their waste operations across their network of hospitals and clinics in the Seattle region. Initially, Republic Services was given the opportunity to replace the current provider at a single site. This has grown into a comprehensive program to manage all their waste spanning 19 locations. Through a dedicated onsite technician with hazardous waste expertise, the customer's staff was relieved from coordinating waste stream and vendor management. Opportunity

Before Republic Services, the healthcare provider struggled with a waste vendor whose service failures disrupted hospital operations. These problems posed risk to staff and patients, added administrative burden and ultimately drove hospital leadership to seek a more reliable, knowledgeable partner.

Solution

Republic Services began with a comprehensive site assessment to identify process gaps, service failures and compliance needs at the main hospital campus. From this, Republic Services developed a tailored strategy focused on onsite support, accurate waste handling and unified program oversight via in depth waste data reports and sustainability goal tracking.

Onsite Technician Deployment

To stabilize operations, Republic Services assigned a dedicated onsite technician at the main hospital. This technician ensured proper collection and staging of waste, maintained accurate pickup inventories, coordinated with nursing and facilities teams and provided consistent communication. The technician quickly became a trusted resource, reducing errors, improving service reliability and relieving staff of time-consuming waste management tasks.

Program Expansion Across the Healthcare Network

As confidence grew, Republic Services expanded to **19 facilities** throughout Seattle, delivering coordinated scheduling, service management and compliance oversight to maintaining consistent standards across the customer's entire healthcare network.

Hazardous Waste and Vendor Management

Republic Services streamlined the expanding program by taking over all hazardous waste operations – profiling, packaging, labeling and transportation – across facilities. By also managing the third-party bio waste vendor relationship, Republic created a single point of contact, reducing vendor management for the customer and enhancing visibility into regulated waste streams.

Enhanced Onsite Capabilities

Republic Services refined onsite processes with regional operations support, standardizing procedures, strengthening compliance tracking and maintaining compliant waste storage areas. The partnership delivered reliability, compliance assurance and operational clarity to support staff and protect patients across the expanding healthcare network.

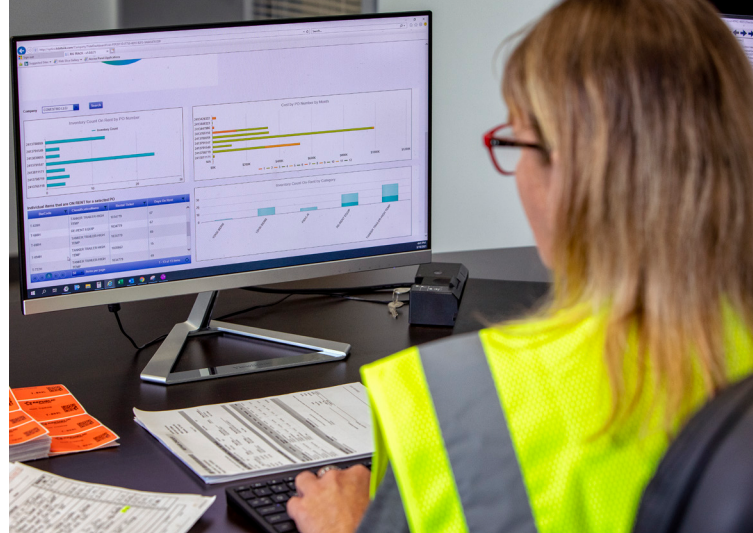
