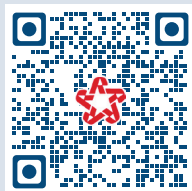

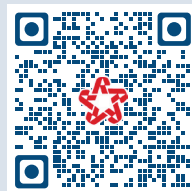

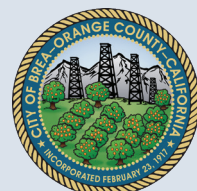

How to Sort Food Waste



Step 1: Set Up Kitchen Containers

Designate an indoor container in the kitchen to collect food waste.



Step 2: Learn How to Properly Sort Food Waste

Property managers are required to provide education yearly and within 14 days of a new tenant moving in. Train household members to separate food waste. Place education near collection containers.



Step 3: Recycle Food Waste

Empty food waste in the outdoor organics container. Food waste should be loose or in a paper bag. No plastic bags or compostable bags are accepted. Tenants should contact their property manager to confirm the location of their outdoor organics container.

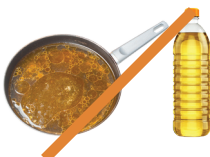

Bulk Item Pickup

Multi-family residents should work with their property management to schedule a bulk item pickup and determine the best location for the pickup. Up to 20 items per collection. Please call **714.238.3300** to schedule a pickup.



Hazardous Waste

Products such as electronics, paint, cleaners, pesticides, batteries and light bulbs require special handling when disposed of. Orange County residents can dispose of these and other household hazardous waste items for FREE at a special hazardous waste facility located at 1071 N. Blue Gum Street in Anaheim, Tuesday through Saturday, 9 a.m. – 3 p.m. Closed on major holidays and during rainy weather. For more information, please visit

State-Mandated Recycling

In 2016, California lawmakers passed Senate Bill 1383 (SB 1383), which mandates organic waste collection services for everyone. SB 1383's purpose is to reduce harmful landfill emission pollutants, like methane, by removing organic materials (food, leaves, grass clippings, etc.). When organic materials decompose in a landfill, as opposed to being properly recycled, greenhouse gas emissions are created that negatively contribute to our environment. This mandatory State law requires everyone in California to do their part and participate in the required recycling and organics collection programs to prevent environmental impacts.

Multi-family and commercial properties are required to recycle their organic waste and other recyclable materials, such as paper, cardboard, plastic, glass and metal. Properties must be subscribed to a recycling and organics program through Republic Services to be compliant with mandates. Tenants and staff can then separate their organic waste and recyclable materials from other waste, and place it in the appropriate container.

The City of Brea and Republic Services are here to help you understand your responsibilities and make it as easy as possible to comply with these mandatory state laws.
