## **Bulky Collection Guidelines**

Republic Services offers Fremont residents two (2) annual by appointment curbside bulky collections free of charge. Customers are required to contact Republic Services at least 2 weeks in advance of the requested collection date by calling 510-657-3500 to schedule an appointment.

## **Clean-up Guidelines**

- Set out household trash, recyclable or organic materials, E-waste, household batteries (bagged in clear, sealed bag), or 2 appliances or large items (not to exceed 150 lbs).
- Group items in a 6x6x6 area in the street, next to the curb.
- All household trash must be bagged, bundled or boxed (except large bulky items).
- Organic materials include yard trimmings not to exceed 12 inches in diameter and 4 feet in length and must be bagged, boxed or tied in bundles.

- If items set-out exceeds 6x6x6, customer will be responsible for an additional bulky item collection fee.
- Place items at your curbside not more than 24 hours in advance but by 5:45 a.m. on your scheduled bulky collection day.
  Do not place items on the sidewalk, driveway, or your property.

Household batteries now collected with your bulky goods.







For the safety of our customers and employees, Republic cannot collect the following items:

- Material that exceeds 150 lbs.
- Nousehold hazardous material (toxic substances, paint, thinners)
- O Construction & demolition debris
- Concrete
- Motor vehicles, auto parts or fluids
- Not ashes
- Animal waste
- Poison oak
- O Commercial refrigerators
- Loose items (small items must be bagged, boxed or tied into bundles)
