

## Mandatory Commercial Organic Waste and Recycling Law

**Assembly Bill (AB) 341 & AB 1826** require businesses generating 4+ cubic yards of waste per week to have recycling service and those generating 2+ cubic yards per week to have organics collection service.

### Senate Bill (SB) 1383 California's Short-Lived Climate Pollutant Reduction Strategy:

Composting organics is the law in California! When organic material (food scraps, food-soiled paper and yard waste) goes to the landfill, it emits harmful greenhouse gas emissions that contribute to climate change.

#### Businesses are required to:

- ✓ Subscribe to a collection service for recycling and organics, and sort waste in the correct container.
- ✓ Annually educate employees on proper waste sorting.

**Edible Food Recovery:** Large food-generating businesses (i.e., supermarkets) may be required to implement a surplus edible food recovery program. For more information, please visit:

**SB 1383 Waivers:** Businesses that generate less than 20 gallons of organic material per week, or lack adequate space for organics containers, may qualify for an organics waiver. Think you qualify? Apply at: [tinyurl.com/1383waiver](http://tinyurl.com/1383waiver).

**Assembly Bill (AB) 827 Customer Access to Organics and Recycling:** Businesses selling food for on-site consumption must provide front-of-house, clearly labeled recycling and organics containers next to trash bins, to collect waste from on-site products. Full-service restaurants must provide labeled recycling and organics containers in back-of-house areas for employee use.

### Senate Bill (SB) 1046 & Senate Bill (SB) 1053:

Starting January 1, 2025, stores may only provide pre-checkout bags that are compostable (meeting state standards) or made from recycled paper. Beginning January 1, 2026, all take-out bags must be recycled paper, with a minimum \$0.10 charge per bag—including at checkout, self-checkout, in-store pickup and delivery. ### City of Richmond Ban of Single-Use Plastic Bags, Polystyrene (Styrofoam™), Plastic Straws, and Plastic Stirrers

### Commercial Hazardous Waste

**Improper disposal of hazardous waste is illegal and dangerous!** Hazardous waste found in ANY of your collection containers is considered contamination and is subject to an additional charge or non-collection. Your business may qualify to drop off waste at the West Contra Costa Household Hazardous Waste Collection Facility in Richmond. ### Locking Containers

Commercial customers may request locking dumpsters or carts. Lock and key service is available for a monthly fee. Please call **510.262.7100** to arrange this service.

### Container Cleaning & Repairs

Our Richmond commercial customers may request one (1) NO-CHARGE exchange of each of their collection containers (recycling, organics and trash) for clean ones once every 5 years. For lost, stolen or damaged containers, please call **510.262.7100** to schedule a repair or delivery.

### Complying with City Requirements

Commercial sites must ensure all actions to comply with state laws also comply with the site's City permits, ADA laws, and fire safety requirements. ### Service Day Guidelines

For missed pickups, general questions or service help, give customer service a call at **510.262.7100**.

- ✓ Metal dumpsters must be accessible for service by 4 a.m. Carts must be curbside by 6 a.m.
- ✓ Lids must close. Overloaded dumpsters may not be serviced, or you may be charged an overage fee.
- ✓ Waste must be sorted into the correct containers. Contaminated dumpsters may not be serviced, or you may be charged a contamination fee.
- ✓ Keep containers accessible and free from obstruction during your service day. Fees may be assessed for return trips.


# Organics

# Recycling

All recyclables must be empty, clean and dry!

## Yes

- ✓ Meat and seafood (including bones and shells)
- ✓ Yard trimmings
- ✓ Fruits and vegetables
- ✓ Food-soiled paper (e.g. napkins, paper towels and brown cardboard)
- ✓ Dairy products
- ✓ Bread



**No bag is best!** If a bag is required, please use paper bags. Plastic bags will be considered contamination.



**NO** – These items are considered contamination and may result in a contamination charge.

- ✗ Plastic
- ✗ Glass
- ✗ Metal
- ✗ Wrappers
- ✗ Batteries
- ✗ Pet waste
- ✗ Diapers
- ✗ Plastic bags
- ✗ Biodegradable or compostable rigid plastics

## Yes

- ✓ Rigid plastic bottles and containers
- ✓ Metal
- ✓ Glass
- ✓ Paper
- ✓ Flattened cardboard



**No bag is best!** Please place recyclables loose in the container. Clear plastic bags or paper bags are the only bags accepted in recycling.

**IMPORTANT:** DO NOT place batteries in ANY collection containers! This creates serious fire risk and endangers the community.
