A. De Minimis

Site receives 2 or more cubic yards/week total solid waste service (garbage + recycling + organics), and generates less than 20 gallons/week organic waste

Site receives less than 2 cubic yards/week total solid waste service (garbage + recycling + organics), and generates less than 10 gallons/week organic waste.

Section 3. Alternative Compliance

Employee(s) transport materials to a recycling facility.

Backhaul

Materials are transported to a central location owned by the business or an affiliate for on-site recycling or shipping to a recycling facility.

Landscaper

Landscaping contractor transports yard waste to a recycling facility.
