

## Mandatory Commercial Organic Waste and Recycling Law

Assembly Bill (AB) 341 Mandatory Commercial Recycling (MCR) requires businesses generating 4 cubic yards or more of trash per week to have recycling service.

Senate Bill (SB) 1383 California's Short-Lived Climate Pollutant Reduction Strategy: Composting organics is the law in California! When organic material (food scraps, food-soiled paper and yard waste) goes to the landfill, it emits harmful greenhouse gas emissions that contribute to climate change.

### Businesses are required to:

- ✓ **Subscribe to a collection service for recycling and organics**, and sort waste in the correct container. All commercial customers in San Pablo are eligible for (1) 65-gal. recycling and (1) 65-gal. organics cart at no additional cost to your waste bill.
- ✓ Annually educate employees on proper waste sorting.

**Edible Food Recovery:** Large food-generating businesses (i.e., supermarkets) may be required to implement a surplus edible food recovery program. For more information, please visit:

**SB 1383 Waivers:** Businesses that generate less than 20 gallons of organic material per week, or lack adequate space for organics containers, may qualify for an organics waiver. Think you qualify? Apply at: [Tinyurl.com/1383waiver](https://Tinyurl.com/1383waiver).

### Customer Access to Organics and Recycling (AB 827)

Businesses selling food for on-site consumption must provide front-of-house, clearly labeled recycling and organics containers next to trash bins, to collect waste from on-site products. Full-service restaurants must instead provide labeled recycling and organics containers in back-of-house areas for employee use.

### City of San Pablo: Single Use Plastic Bag & Polystyrene Ban



The City of San Pablo has banned single-use plastic bags and polystyrene foam (Styrofoam™) in retail establishments and food providers under Municipal Code

## Commercial Hazardous Waste

**Improper disposal of hazardous waste is illegal and dangerous!** Hazardous waste found in ANY of your collection containers is considered contamination and is subject to an additional charge or non-collection. Your businesses may qualify to drop off waste at the West Contra Costa HHW Collection Facility in Richmond. ## Locking Containers



Commercial customers may request locking dumpsters or carts. Lock and key service is available for a monthly fee. Please call **510.262.7100** to arrange this service.

## Container Exchanges & Repairs

Every 5 years, our San Pablo commercial customers may request one (1) **no-charge** exchange of each of their collection containers (recycling, organics and trash) for clean ones. For lost, stolen or damaged containers, please call **510.262.7100** to schedule a repair or delivery.

## Service Day Guidelines

For missed pickups, general questions or service help, give customer service a call at **510.262.7100**.

- ✓ **Metal dumpsters must be accessible for service by 4 a.m.** on service day or set out the night before. **Carts must be curbside by 6 a.m.** or the night before.
- ✓ **Lids must close.** Overloaded dumpsters may not be serviced, or you may be charged an overage fee.
- ✓ **Waste must be sorted into the correct containers.** Contaminated dumpsters may not be serviced, or you may be charged a contamination fee.
- ✓ **Keep containers accessible and free from obstruction** during your service day. Fees may be assessed for return trips when a dumpster is blocked from access at the time of collection.



### Holiday Schedule

If any of the following holidays falls on a Monday–Friday, service will be delayed by one day for the remainder of the week: July 4 (Independence Day), Labor Day, Thanksgiving, Christmas Day, New Year's Day.

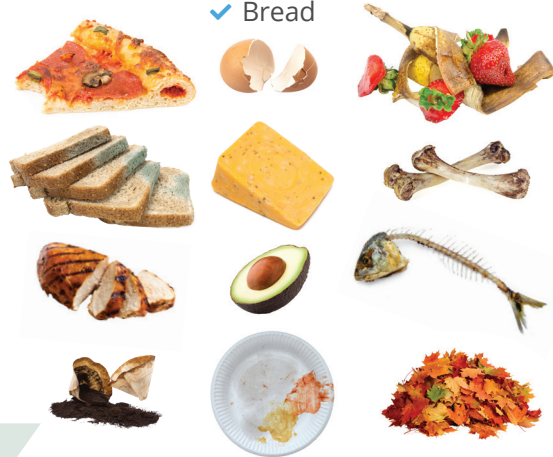
# Recycling

All recyclables must be empty, clean and dry!

# Landfill

## Yes

- ✓ Meat and seafood (including bones and shells)
- ✓ Yard trimmings
- ✓ Fruits and vegetables
- ✓ Food-soiled paper (e.g. napkins, paper towels and brown cardboard)
- ✓ Dairy products
- ✓ Bread



No bag is best! If a bag is required, please use paper bags.



## No – These items are considered contamination

- ✗ Plastic
- ✗ Glass
- ✗ Metal
- ✗ Wrappers
- ✗ Pet waste
- ✗ Diapers
- ✗ Plastic bags
- ✗ Biodegradable or compostable rigid plastics

## Yes

- ✓ Rigid plastics
- ✓ Metal
- ✓ Glass
- ✓ Paper
- ✓ Flattened cardboard



No bag is best! Please place recyclables loose in the container. If bag is required, please use clear plastic bags or paper bags ONLY.
